

ORDER

Ministry of Railways (Railway Board) have decided to constitute a Committee, to make recommendations with respect to modalities for implementation of the pronouncement made in the Railway Budget Speech 2011-12 in para 56 (ii), viz., extending medical facilities to both dependent father and mother of railway employees, consisting of the following:-

- i). Chairman/HRRC, Railway Board
 - ii). Executive Director/Health (G), Railway Board
 - iii). Executive Director/Finance (Estt), Railway Board

2. The Terms of reference of the Committee will be as under:-
- "To make recommendations with respect to modalities for implementation of the scheme for extension of medical facilities to both dependent father and mother of railway employees, including determination of eligibility criteria, procedure for enrolment, etc."*
3. The Committee should submit its report within a period of two months from the date of its constitution.
4. The Headquarter of the Committee will be at New Delhi.
5. The Convener and Members of the Committee shall be eligible to draw TA/DA as admissible under the extant rules.
