

Record note of discussions held by EDE(N) with AIRF on 08.07.2013 in his chamber on PNM/AIRF item No. 50/2012; (A) Classification of Railway services consequent upon introduction of RS (RP) Rules, 2008 – Eligibility for Selection to Group 'C' post in General Categories. (B) Consideration of staff in erstwhile group 'D' categories since upgraded as Group 'C' for promotion to the posts of Stenographers (GP Rs. 2400), Hindi Asstt. Gr. II (GP) Rs. 2800.

It was agreed that all erstwhile Group 'D' categories since upgraded as Group 'C' can be considered for selection to Gr. 'C' posts including the posts of Stenographers (GP Rs. 2400), if they possess the required eligibility criteria i.e. necessary educational qualification, residency period and have put in the requisite number of years of service etc.

However, since Hindi Asstt. Gr. II (GP Rs. 2800) are 100% directly recruited, the staff in erstwhile Gr. 'D' categories since upgraded as Group 'C' cannot be considered for promotion as Hindi Asstt.
