

ORDER

Ministry of Railways (Railway Board) have decided to constitute a Committee to review air conditioning facilities and other equipment specifications for PRS & UTS centres located in suburban section of Mumbai area in Western and Central Railways to improve the reliability of equipment in humid and temperate conditions, consisting of the following:-

1. Executive Director(EEM), Railway Board ..... Convenor
  2. Executive Director(C&IS), Railway Board ..... Member
  3. Executive Director(Tele), Railway Board ..... Member
  4. Executive Director/F(X)-II, Railway Board ..... Member
2. The Terms of reference of the Committee are as under: -
- (i) To identify the problem of reliability of UTS machine in adverse conditions prevailing in Mumbai area (WR/CR) with regard to humid and temperate zone and to take views of stakeholders;
  - (ii) Identification of technological solution by upgrading hardware equipment to enhance performance of UTS/PRS in adverse climatic condition;
  - (iii) To revise air conditioning norms for solving problems, if any; and
  - (iv) To suggest energy efficient solution.
3. The Headquarter of the Committee will be at New Delhi.
4. The Committee should submit its report in two months from the date of its constitution.
5. The Convener and Members of the Committee will be eligible to draw TA/DA as admissible under the extant rules.
