
2. The terms of reference of the Committee will be as under: -

The Committee will look into the issues raised by various Federations/Unions/Associations and will also seek views from Federations, Associations, Unions and employees as considered appropriate regarding :

- Grade pay and fixation of pay on promotion vis-à-vis direct recruitment;
- Allowances to Loco Running Staff as per the recommendation of Sixth Pay Commission;
- Applicability of running allowances with effect from 01.01.2006 based on revised rate of running allowance and related demands;
- Computed running allowance in suburban sections; and
- Any other issue/demand which is referred to the Committee.
