As per the unanimous resolution passed in the working committee meeting of AIRF held at NDLS on 18/19-3-10, All India Protest Day was observed by WREU Bhavnagar division on 26/5/10 against the decision of Railway Board's order for surrendering of posts, abnormal delay in filling up of existing vacancies and non creation of additional post for increased work load, outsourcing of existing work to contractors and other anti-labour attitude of Railway administration. The Dharana, Demonstration, Slogan shouting and Open meeting was held before DRM office BVP from 10.00 hrs to 13.00 hrs. Largely attended gathering was addressed by Com. V K Sharma, Divl.
