## **MEMORANDUM**

Sir,

### **Sub: All India Protest Day – 18<sup>th</sup> May,2011**

We are constrained to draw your attention to the following for appropriate redressal to minimize the ongoing staff resentment . Consequent upon acceptance of 6<sup>th</sup> CPC recommendations w.e.f. 01.01.2006 most of the allowances have been enhanced. A demand from both AIRF & NFIR was made to extend the benefit of overtime w.e.from 01.01.2006 treating it as segment of salary. Assurance was communicated in the DC/JCM meeting held on July,2010 that letter to this effect would be issued after 31.03.2011.

On 2<sup>nd</sup> May 2011 AIRF & NFIR leadership made it clear to Addl. Member Staff/Rly. Board in a separate meeting, that the Federation will not hold DC/JCM meeting unless letter for payment of OT allowance w.e.from 01.01.2006 is given during DC/JCM meeting itself.

But till the evening of 4<sup>th</sup> May, 2011 the letter was not made available.

In the face above, leadership of AIRF & NFIR took decision not to hold DC/JCM meeting on 5<sup>th</sup> May,2011.

On this stand of AIRF & NFIR Member Staff, Rly.Board called the federations and urged upon to continue the meeting but the leadership maintained their stand as before and boycotted the meeting on 5<sup>th</sup> May, 2011.


In view of the above, it was decided to observe "All India Protest Day" on 18<sup>th</sup> May, 2011 throughout the Indian Railways on the following Charter of demands .

- i.) **Payment of overtime Allowance, arrears w.e.f.01.01.2006 instead of 31.08.2008**
- ii) **Payment of settlement dues to staff working in construction organisation on their last pay drawn.**
- iii) **Immediate finalization of report of the committee on trackman.**
- iv) **Payment of arrears of Running allowance w.e.f 01.01.2006 and also increase kilometerage allowance.**
- v) **Filling up of large no. Vacancies on Railways**
- vi) **Immediate implementation of recommendation of anamolies committee.**
- vii) **Immediate restructuring of cadre of all the categories.**

You are requested intervene to remove the impasse.


